OPENING DATES FOR 2025

January 1 to January 31, 2025 Barbless hook

Fish that can be caught :

Carp, bream , roach , rudd And tench **NO-KILL**

Pike NO-KILL.

American crayfish

February 1 to February 28, 2025 **Only the single barbless hook is allowed!**

Only natural baits are allowed on single barbless hooks.

The use of spoons, lures, paddles or any other techniques is prohibited.

Fish that can be caught :

Carp, bream, roach, rudd, tench and **pike NO-KILL**

American crayfish

March 1 to June 6, 2025 **Only the single barbless hook is allowed!**

Only natural baits are allowed on single barbless hooks.

The use of spoons, lures, paddles or any other techniques is prohibited.

Fish that can be caught :

Carp, bream, roach, rudd and tench **NO-KILL**

American crayfish

Perch, trout and brook trout over 24 cm *

June 7 to December 31, 2024 Barbless hook

Fish that can be caught :

Carp, bream, roach, rudd, tench, minnow, dace, gudgeon, bleak **NO-KILL**

NO-KILL Grayling and **Pike**

Trout, perch and brook trout over 24 cm *

American crayfish, chub

Fishing is practiced from one hour before the official time of sunrise until one hour after the official time of sunset.

Before fishing you need:

THE WALLOON REGION LICENSE

1-Waterfront permit A

2-B license for fishing in water and **crayfish**

3-Youth permits up to 15 years old **free** only with certain restrictions

4-Tourist permit equal to permit B and valid for 15 days

ANY PERSON INTENTIONALLY WISHING TO FISH ON THE LAKE MUST BE IN POSSESSION OF THEIR FISHING LICENSE AND THE WALLOON REGION PERMIT AND HAVE READ THE LAKE REGULATIONS AND ACCEPT ALL OF THEIR TERMS

A fishing license is compulsory from the age of 14. Any young fisherman not accompanied by an adult holding fishing rights must be in possession of their own personal fishing license.

Children under 14 years of age fishing are authorized to use only a **single hand line** with a **single barbless hook and** are exempt from the Walloon Region permit on Saturdays, Sundays, public holidays and during school holidays, provided that they are accompanied by an adult in possession of a RW permit.

For annual cards you can recover part of the amount of affiliation to a sports club from your mutual insurance company; you must request a form from your mutual insurance company and LA SALMIOTE will complete it and send it to us by email.

REGULATION

THE PROHIBITIONS AND OBLIGATIONS OF SALMIOTE.

- 1: Night fishing is prohibited.
- 2: Wading (fishing with your feet in the water) is prohibited
- 3: Fishing from boats and all other vessels is prohibited.
- 4: Fishing and baiting with blood, marrow and bloodworms are prohibited.
- 5 : Boats for baiting, laying lines and echo sounders are prohibited.
- 6: **Barbed hooks are prohibited.**
- 7 The recommended priming is limited to 5 litres of groundbait flour and 1 litre of maggots maximum.
- 8 For pike fishing with live bait: only single barbless hook
- 9 Any fish caught that is smaller than the regulated size must be returned to the water without being disgorged . **Obligation to cut the leader**
- 10 For white fishing, **the landing mat is mandatory.**
- 11 The use of a **dry cloth** for No-Kill fishing is prohibited.
- 12 Obligation to use a suitable drain cleaner.
- 13 The online fishing card must be accompanied by the catch control card also available on site. Without this card, the fisherman must practice total NO-KILL: (prohibition on keeping fish)

14 Obligation to use the landing net

RW FISHING RULE

- 1: The basket is forbidden
- 2: Only two handlines may be used simultaneously by a fisherman who must be in direct proximity to them and able to monitor them constantly.

NUMBER OF SOCKETS ALLOWED

Day pass: 5 fish maximum

Pike and grayling NO-KILL

Carp, bream, roach, rudd and tench **NO-KILL**

Weekly menu : 10 fish maximum per week.

Carp, bream, roach, rudd and tench **NO-KILL**

Pike and grayling NO-KILL

Annual card: 60 fish maximum, all fish combined

With 10 fish maximum over 7 consecutive calendar days

Carp, bream , roach , rudd tench **Pike NO-KILL**

CONTROL AND SOCKET CARD

The catch control card is printed on the back of each permit. To be completed by the fisherman after each catch retained before resuming fishing.

1-by the date from the first fish preserved

2-by the first letter of the fish: ex **T** for trout , **B** for pike for **P** perch before starting to fish again

3-If the fisherman is no longer carrying his fish, he must circle the boxes of the fish concerned ex T

Any fisherman who has reached the number of daily catches allowed must stop fishing and put away his equipment so as to no longer be in a fishing position.

We draw your attention to the number of sockets authorized by the Walloon Region

The committee asks fishermen to only take fish for their personal consumption and reminds that it is forbidden to sell it

SURVEILLANCE

Surveillance is provided by the Company's guard and committee members upon presentation of their control card.

Any fisherman checked in fishing attitude on the course of the company 'LA SALMIOTE' must SPONTANEOUSLY present his fishing license and his identity card thus allowing the controller to verify whether or not the fisherman respects the regulation, namely to be in possession of his fishing license which is STRICTLY PERSONAL.

If not, the fisherman must:

Either stop fishing and leave the fishing route and pay compensation of 2 x the price of the weekly permit and seizure of all catches

The fisherman must authorize the inspection of his catch. If it is in a vehicle, he must authorize the inspection of the vehicle as well as all baskets, keepnets, bags and pockets etc.

Fair play is essential in all situations (respect places and distances between fishermen)

SANCTIONS PLANNED:

Non-exhaustive list

IMPORTANT: The penalty provided for in the event of a breach of the regulations provides for the immediate withdrawal of the permit for a minimum period of one week. After this period, the fishing permit may be collected from the home of the president (or his representative) **EXAMPLE of penalty - Fish not registered = one week of withdrawal** In the event of a repeat offence, the fishing permit will be permanently withdrawn and an exclusion will be made

- * *Being engaged in unauthorized fishing "night fishing" for the first time* : Warning with 1 week withdrawal of fishing license
 - * *Being engaged in unauthorized fishing "night fishing" for the second time* : Exclusion from society
 - * *Refuse socket control* : Exclusion from society
 - * *Having cut off the head in one or more takes* : Exclusion from society
 - * *Be in excess of the number of authorized sockets* : Exclusion from society
 - * *Unauthorized capture dead or kept alive* : Exclusion from the company
 - * *Taken less than the legal size and retained* : Exclusion from the company
 - * *First time boot not allowed*: Warning with 1 week card withdrawal
 - * *Unauthorized priming second time* : Exclusion from the company
 - * *Fishing action during the closed period for restocking for the first time* : Warning and 1 week withdrawal of the fishing license
 - * *Fishing action during the closed period for restocking for the second time*: Exclusion from society
 - * Any lack of respect and/or correctness towards the company or towards one of its representatives: Exclusion from the company
 - * Any fishing offence with a day or week permit: Automatic revocation of the permit
- In the event of a repeat offence: Permanent exclusion from the company

The committee reserves all rights to sanctions.

RESPECT THE PLACES AND USE THE BIN & PARKING LOTS :

The fisherman cannot park his vehicle on the lawns, in front of homes or holiday apartments (including Houyoux). Use the main car parks: at the lake embankment, around Lac des Doyards or in front of the sports hall. **Parking along the banks is strongly discouraged and is the responsibility of the fisherman in the event of an accident or damage.**

It is requested to respect the PMR locations according to the regulations posted for this purpose

CRAYFISH FISHING

Only holders of a **B permit** from the Walloon region can fish it.

Crayfish scales cannot exceed sixty centimeters

Driving license B: 5 Balances Young driver's license: 1 Balance

Animal offal is used as bait in the scales, it cannot be attached to the hook of a hand line

Restocking dates: Please note that fishing closes at 6 p.m.!

February 28, March 28, April 25, May 16, June 13, July 13, August 8

For info: in October or November: perch, roach, carp, tench depending on availability, no fishing closure.

The committee may remove or postpone any restocking notification on the company's website.
